BY-LAW #1566

BEING A BY-LAW TO ESTABLISH FEES, RENTAL AGREEMENT FORM, AND POLICY  
ON THE USE OF  
THE HILLIARDTON COMMUNITY HALL AND PROPERTY

WHEREAS, the Municipal Act, R.S.O. 2001, Part 2 Sec.3 & 4 (58)(c)(g) provides that the Council of a Municipality may establish a policy for the usage of a Community Recreation Centre;

NOW THEREFORE BE IT RESOLVED:

1. THAT the prescribed fee for usage of the Community Recreation Centre is set as  
Weekdays = \$75  
Fridays/Holidays = \$100  
Celebration of Life etc. for a Hilliard Resident = \$40  
Blanche River Golden Age Club = \$50
2. THAT the user must sign an agreement, attached hereto as "Schedule A" and forming part of this by-law
3. THAT this By-Law comes into force and effect upon final passing hereof and By-Law #1459, By-Law #909, and By-Law #1377 are hereby repealed
4. Any currently booked dates will be honoured at previous rates until and including September 1<sup>st</sup> 2020.

READ A FIRST TIME this 17<sup>th</sup> day of June, 2020.

READ A SECOND TIME this 17<sup>th</sup> day of June, 2020.

READ A THIRD TIME AND FINALLY PASSED this 17<sup>th</sup> day of June, 2020.

**BY-LAW #1566 - SCHEDULE "A"**  
**HILLIARDTON COMMUNITY HALL RENTAL AGREEMENT**

THE PERSON OR ORGANIZATION SIGNING BELOW AGREES TO THE FOLLOWING RULES &  
REGULATIONS FOR HALL RENTAL:

1. The hall rental fee must be paid before or when the key is picked up.
2. The hall must be vacated and the door locked not later than 1:00 a.m. and left as follows:
  - the dishes, equipment and kitchen must be cleaned and left in the same condition as found
  - the hall should be left free of loose dirt (glasses, bottles, streamers, etc.) and table tops left clean, all cigarette/cigar butts are to be cleaned up and safely removed from property
  - the tables are to be taken down and returned to the storage area under trophy case
3. The Renter shall remove any unused supplies or non-Community Centre equipment not later than 1:00 a.m. The Township of Hilliard will not be responsible for items left after this time.
4. The Renter shall bring their own tablecloths, soap, tea towels, dish cloths, etc.
5. Replacement costs will be charged, to the person/organization signing this Agreement, for any breakage, damage, or articles missing from hall or premises.
6. The Renter will be responsible that no undue noise or unbecoming behaviour will be allowed at any time in the premises or in the vicinity of the Hall.
7. No music (live or recorded), speaker systems, microphones etc. are to be played/performed/used during weekdays from the hours of 9am to 5pm.
8. Parking is permitted only in the designated parking lot. No vehicles are permitted on the lawn.
9. No beer, wine or spirits of any kind are permitted.

Failure to comply with any of these rules may result in a ban from using the Hall in the future.
