BY-LAW #1578

**BEING A BY-LAW TO APPOINT OFFICERS AND MEMBERS OF COMMITTEES IN/FOR THE TOWNSHIP OF HILLIARD, AND TO REPEAL BY-LAW #1532, A BY-LAW TO APPOINT OFFICERS IN THE TOWNSHIP OF HILLIARD, AND TO REPEAL BY-LAW #1531, A BY-LAW TO APPOINT MEMBERS TO COMMITTEES IN THE TOWNSHIP OF HILLIARD**

**WHEREAS** the council of every municipality has the authority under the Municipal Act, 2001, Chapter 25 as amended, to enhance their ability to respond to municipal issues;

**AND WHEREAS** the council of every municipality shall appoint valuers of livestock, poultry and honey bees, Livestock, Poultry & Honey Bee Protection Act, R.S.O. 1990 as amended, Chapter L24, Part 1, Section 4(1);

**AND WHEREAS** the council of every municipality shall appoint fence viewers, Line Fences Act, R.S.O. 1990 as amended, Chapter L.17, Section 2;

**AND WHEREAS** the council of a municipality who issues tile drainage loans shall appoint a Tile Drainage Inspector, Tile Drainage Act, R.S.O. 1990 as amended, Chapter T.8, Section 4;

**NOW THEREFORE, BE IT HEREBY ENACTED THAT** the following persons are appointed to serve in the various offices and committees in/for the Township of Hilliard until November 30th, 2022:
