



THE CORPORATION OF THE TOWNSHIP OF HILLIARD

BY-LAW 2023-09

**RIGHT OF ENTRY FOR THE PURPOSE OF REGULATING, MAKING REPAIRS OR ALTERATIONS**

**BEING A BY-LAW OF THE TOWNSHIP OF HILLIARD AUTHORIZING TOWNSHIP STAFF AND HIRED CONTRACTORS TO ENTER ONTO LAND/PROPERTY IN ORDER TO REGULATE AND/OR REPAIR PLACES OF DANGER; OR TO REPAIR/PREVENT/MITIGATE DAMAGE TO OR REPAIR PLACES AND/OR INFRASTRUCTURE IN THE INTEREST OF PUBLIC SAFETY.**

**WHEREAS** the Municipal Act, Section 123, states that a local municipality may, for the purpose of public safety, regulate with respect to cliffs, pits, deep water and other dangerous places; AND

**WHEREAS** the Municipal Act, Section 8, enables the municipality to govern its affairs as it considers appropriate and to enhance the municipality's ability to respond to municipal issues; AND

**WHEREAS** the Municipal Act, Section 8, allows the municipality to create a By-Law which requires persons to do things respecting the matter; AND

**WHEREAS** the Municipal Act, Section 10, allows the municipality to provide any service or thing that it considers necessary and desirable to the public

**NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF HILLIARD ENACTS AS FOLLOWS:**

1. TOWNSHIP STAFF AND HIRED CONTRACTORS MAY ENTER ONTO LAND/PROPERTY IN ORDER TO REGULATE AND/OR REPAIR PLACES OF DANGER; OR TO REPAIR/PREVENT/MITIGATE DAMAGE TO OR REPAIR PLACES AND/OR INFRASTRUCTURE IN THE INTEREST OF PUBLIC SAFETY
2. LANDOWNERS ARE TO BE NOTIFIED, IN WRITING, NO LESS THAN 48 HOURS PRIOR TO ENTRY ONTO THE LAND UNLESS IT IS DEEMED BY TOWNSHIP STAFF THAT THERE IS AN IMMEDIATE THREAT TO PUBLIC SAFETY
3. LANDOWNERS WILL BE PROVIDED WITH NAMES, IN WRITING, OF ANY COMPANIES/CONTRACTORS PERFORMING THE WORK
4. LANDOWNERS WILL BE PROVIDED, IN WRITING, WITH THE REASON FOR ENTRY ONTO THE PROPERTY
5. LAND AFFECTED BY THE ENTRY (OTHER THAN THE SITE OF WORK) SHALL BE LEFT IN THE SAME CONDITION AS IT WAS PRIOR TO ENTRY
6. THE ENTRY IS ONLY PERMITTED FOR THE DAY(S) SPECIFIED IN THE WRITTEN NOTICE
7. THIS BY-LAW SHALL TAKE EFFECT IMMEDIATELY UPON THIRD READING THEREOF

**READ A FIRST, SECOND AND THIRD TIME THIS 22<sup>ND</sup> DAY OF MARCH, 2023.**
